

**Camden Christian Academy**

The mission of Camden Christian Academy is to assist parents and local Bible-believing churches in providing a quality Christian education for young people in an environment where they will be encouraged to receive Jesus Christ as their personal Savior, and will be motivated to commit their lives to serve Him.

CCA desires to be partnered with parents and churches in the training of young people. Although academics are considered to be vital in accomplishing this goal, the spiritual development of students is the primary focus of CCA. Parents who desire that their children be trained in an environment where the Word of God is put first are encouraged to enroll their children at CCA. These scholarships are intended to help Christian parents be able to enroll their children at CCA.

Scholarships that are awarded will be announced around the first week of August 2008. Applications will be kept on file until the end of the school year.

Scholarships include tuition only. Parents are responsible for all other charges including registration, sports fees, and any other charges outside of the portion of the tuition paid by a scholarship.

Scholarships must be applied for each year. Having received a scholarship one year does not guarantee a family of receiving a scholarship the following year.

**CCA Enrollment**

The student must complete the enrollment procedures, which will take approximately two weeks, as outlined in the CCA Parent/Student Handbook, and be accepted for enrollment prior to being considered for a scholarship.

**Parental Involvement**

In order for CCA to be able to help in training Christian young people, the home and school must be working towards the same goal. Parents, therefore, must submit a letter of recommendation from their pastor stating that they are members in good standing and are actively involved in their church ministry.
